<p>Updates</p> <ul style="list-style-type: none"> PHIP Funding and Advocacy Updates 	<p>Governor Cuomo has proposed the elimination of PHIP funding, updates include:</p> <ul style="list-style-type: none"> The PHIP grant was scheduled to end January 2020, but the proposal would end the program in April 2019 According to the governor's office, if the legislature includes PHIP funding in the upcoming budget, their office will not oppose it LIHC is concentrating their efforts on working with state legislators, NSHC CEO Kevin Dahill and others are advocating in Albany LIHC members are encouraged to sign and send letters to their state representatives expressing the value they find in the PHIP program

To ensure integrity, Paul has compared the data collected from the community health assessment surveys to the ACS information from the census bureau. Two areas are lacking in representation, and the CHNA data advisory group is working together to gather more robust information.</p> <p>Chronic Disease Self-Management Programs – An awareness campaign for CDSM was created, which is represented by a landing page on the LIHC’s website. To engage and educate the community, a testimonial video has been put together to show an example of how one Long Islander has changed his lifestyle and health.</p>

<p>Long Island’s Healthy Libraries Project</p>	<p>In partnership with their academic partners, the LIHC has embarked on an asset mapping project to uncover the health- and social-service related programming occurring at public libraries throughout Nassau and Suffolk counties. Through this project, relevant programs hosted at libraries have been identified, based on the New York State of Health Prevention Agenda’s five priority areas - Prevent chronic diseases; Promote healthy and safe environments; Promote healthy women, infants and children; Promote mental health and</p>

	<p>prevent substance abuse; Prevent HIV, sexually transmitted diseases, vaccine-preventable diseases and healthcare-associated Infections. Interactive maps have been created and posted on the LIHC website, for community members to find relevant programs in their neighborhoods. A separate research-based page is available to health professionals and includes maps that show the level of need, social determinants of health, and which prevention agenda topic is targeted.</p>
<p>The Opioid Crisis on Long Island – a Data-Driven Population Health Approach</p> <ul style="list-style-type: none"> Presented by Lisa Benz Scott, Ph.D., Director, Program in Public Health and MPH Program Lisa.Benzscott@stonybrook.edu 	<p>Dr. Lisa Benz Scott addresses the collaborative on the opioid crisis on Long Island and its effect on community libraries. Due to the many assets libraries possess, i.e., heat/air conditioning, compassionate staff, private bathrooms, they have become an effective resource in addressing social determinants of health. Multiple methods of research were conducted by both Stony Brook University and Hofstra University to determine “hot spots” for opioid poisonings on Long Island, and their proximities to libraries. The “hot spots” were used to consider what libraries are currently doing in terms of mental health and substance abuse, and what opportunities there are for libraries to do more. Some determinations of their research are that there is a critical need for evaluation of the existing programs and how to successfully replicate them and that there is a need for additional programs in hot spot areas such as the Bayport Blue Point Public Library.</p>
